SELFIE AGE VERIFY



By simply taking a static selfie, our cutting-edge facial estimation technology can identify a user's age in real-time (no ID needed). If the user is not the age they say, or within a predetermined acceptable range, Document Age Verification can be triggered as an additional verification step.

Our solution includes iBeta Level 2 Presentation Attack Detection (PAD 2) technology that detects liveness to ensure users are taking the selfie in real-time to prevent any spoofing. With iBeta certified liveness detection, you can detect spoofing tactics like users taking a picture of a physical photo, digital image, a 3D printed mask, or even a deep fake video.

DOCUMENT AGE VERIFY



Fast, accurate identity document scanning extracts the user's date of birth for age verification. Set the age to verify, whether the person is 18, 21, or even 12 for underage social media accounts. With pass or fail decisioning, the exact age is optional to disclose to the verifying party. Plus, with stateless processing enabled, all PII data and images can be deleted instantly.

In addition to extracting a user's date of birth, AuthenticID's proprietary technology combines machine learning and AI to review over 2,000 unique computer vision data models to verify the ID's authenticity and extract all Personally Identifiable Information (PII) as well as any other information from the ID.



SELFIE + DOCUMENT AGE VERIFY

Users can start the age verification process with a simple selfie image. If the selfie falls within an age range that is close to the customer's approved parameters, the user can be prompted to then capture their government issued ID as a step up. (Document Age Verify)

Users can also be prompted to capture both the ID and the selfie for extra validation and underwriting and to establish the person's age and confirmation they are who they are claiming to be.

Social Media

Confirm age with timestamped underwriting before users open accounts or prior to uploading or viewing content.
